Online Application Will Be Launched for Visa Direct AFT Program Approvals

Global Acquirers, Issuers, Processors





Overview: Acquirers will be required to submit a Program Information Form for new Visa Direct account funding transaction (AFT)-only programs through the Program Request Management tool at Visa Online. The online application will be open for submissions starting 14 February 2020.

Program Information Forms (PIFs) will be required for Visa Direct AFT-only programs to enable transaction monitoring and tracking for these programs. PIF submissions are limited to acquirers. Acquirers are required to communicate these changes to their agents and processors.

Mark Your Calendar:

- Acquirers must submit program approvals for AFTonly programs through PRM (14 February 2020)
- Acquirers are required to submit PIFs for new AFT-only programs using the Program Request Management application, which will begin accepting submissions on 14 February 2020.

Background

An AFT is a VisaNet transaction used to pull funds from a Visa card account in order to fund a different, nonmerchant account. An AFT must not be used for the payment of goods and services, funding of a merchant account or debt repayment.

Visa requires the AFT be used as the funding transaction for the use cases of money transfer, wallet pre-funding and prepaid card funding in a card-absent environment.

AFT use cases include:

- Funding a digital wallet, for example adding funds to a digital wallet in order to send money to another person
- Loading or topping up a prepaid card account
- Moving funds between accounts, for example, funding a savings deposit account from a checking account

Enrolling in Visa Online

Acquirers that do not have access to Visa Online are encouraged to enroll and become familiar with the Visa Direct section.

To become a registered user of Visa Online, go to www.visaonline.com. You will need your Business Identification (BID) number to enroll. If you do not know your organization's BID, contact your manager or the Visa Online administrator. Upon enrollment, you will receive a user ID and password to access PRM when it becomes available.
